

Print this out and bring it with you

When you are on the plane a flight attendant will hand you customs/immigration forms to fill out. Please see the forms below. On the green form it will ask for the address you are staying at in Haiti. Here you will fill in: Hotel Ibolele in the city of Petionville. You do not need to fill in the street, just put the hotel name on that top line. Put your passport number, flight number and signature onto the form. The customs form is attached and is self-explanatory.

After exiting the plane, you will need to **pay the immigration agent 10.00 cash per missionary** to enter the country of Haiti. The agent will tear off the small bottom square of your green immigration card and place it back into your passport. Please don't lose this green card as you will need to have it handy when you are departing Haiti at the end of the week!

Please **use the bathroom in the airport**. There will not be another bathroom break until a few hours into the drive. There is a bathroom downstairs in the baggage claim area. This is where we typically use our insect repellent wipes before heading outside.

Men will try to help you with your bags while inside the airport. If you don't need help (assuming you don't have checked bags) then just say "no merci". If you do need any help, then please allow Manno to tip them. Don't worry about tipping anyone yourself and never take out any money. Just let Manno know who helped you and that you haven't tipped them.

Joe will be the driver picking you up at the airport. Manno, our mission director, will also be there. They will be waiting at the gate (literally a gate... or a fence, outside of the airport).


Don't panic if you don't see them right away, they are probably just having a hard time finding a parking spot~
